Greeting JCSD Board Members. Hope all is well. Water quality for May were good. The district sold construction water at the HLC and park wells this month. LIHWAP (Low Income Household Water Assistance Program) is still offering eligible customers with a one-time payment credit on water bills and as well as payment assistance for past water bills. Currently waiting for laboratory to make up a sample kit for Highland Center Well for water samples. Starting July 1st districts water rates and usage fees go up 5%.
